Ref: Correspondence ending with your letter
dated the 30th March and 10th April 1950.

I have the honour to inform you that the Syndicate has considered the correspondence relating to opening of the B.T. Degree course in the Sri Ramakrishna Mission Vidyalaya, Perinjeenkulam, and resolved that provisional affiliation be granted for a period of three years in the subjects detailed below from the academic year 1950-51, subject to the specific conditions regarding separate accommodation, equipment, number of trainees, time-table, endowment etc. mentioned by the Inspection Commission and communicated in this office letter No. A.1209 dated the 25th March 1950, and that the teaching staff should be as follows:-

Subjects

All the compulsory subjects and the following optional subjects:-

Tamil
Mathematics
Social Studies
Basic Education.

Teaching staff

5 Professors (one of whom should be the Principal), in the grade of Rs. 200-500.

1 Lecturer for each of the optional subjects in the grade of Rs. 150-250.

The Principal of the College should be in the grade of Rs. 500-600. Attention is also invited to this Office letter No. A.1279 dated the 29th March 1950 regarding qualifications and conditions of salary prescribed for Lecturers in Training Colleges.

In communicating the above resolution I have recommended that if all the optional subjects mentioned above are taught, there should be three Professors and four Lecturers besides a Physical Director and a Librarian. Attention is also invited to para. 1 of the General Report of the Inspection Commission in regard to appointment of Professors and Lecturers for the principal subjects and optional subjects.

The number of students to be admitted should not exceed 50.

There should be a Governing Body for the College on which the Principals will be a member or-official and a nominee of the University. The Governing Body may consist of not more than 9 members.

There should also be a College Council consisting of the Principal and members of the teaching staff.

The functions of the above bodies will generally be the same as those applicable for Arts and Science Colleges. (Vide recommendations of the University General Inspection Commission, 1946-47, Part II - Chapter I).

In this connection I am to invite your attention to the principles laid down by the Syndicate in regard to opening of new training colleges previously communicated to you in my letter No.A.10 dated the 3rd January 1950.

I am to request you to forward a preliminary report by the 5th June 1950 on the arrangements made for opening the classes giving details regarding accommodation, equipment, staff, hostels for men and women students etc. A further report may be sent by the 31st July 1950 on the opening of classes in the new courses, number of trainees admitted, staff appointed, etc. and how far the several recommendations of the Commission have been given effect to.

With reference to your letter dated the 12th April 1950 regarding transfer of properties for the College Endowment, a separate communication is being sent.

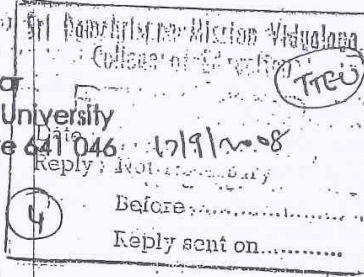
