- 1) The number of posts mentioned in column 4 and 5 are temporary. The number of teachers working in 1998-1999 and 1999-2000 is given assuming that the posts allowed to be filled up are filled up. Therefore, the number of posts to be filled and the number of existing teachers mentioned in column 3 should not be excessive.
- 2) There should not be more teachers than the number of posts allowed in the column 3 under any circumstances. In such case no grant will be allowed for the excessive posts.
- 3) The Educational qualification and other procedures mentioned in Ordinance No.111 and 113, by the Department of Higher Education, dated 24.03.1999 shall be strictly followed at the time of appointment.
- 4) Non- minority colleges should appoint the posts by getting list of candidates from employment office as per norms and following communal roaster system.
- 5) The Joint Director of Collegiate Education shall register the subject wise number of posts allotted for grant t in the concerned office register.
- 6) A separate order is issued to transfer the surplus teachers mentioned in column 6 to other colleges under the transfer scheme.
